1.1 CHANGES TO BID DOCUMENTS

- 1.1.1 General Conditions have been added to Bid Documents, consisting of pages 1-1 to 16-1. This has been inserted on pages 41 to 102 of the PDF.
- 1.1.2 Contract has been added to Bid Documents, consisting of pages F-1 to F-6. This has been inserted on pages 21 to 26 of the PDF.
- 1.1.3 DESCRIPTION OF WORK has been changed to the following:

This project consists of removal and disposal of one (1) submerged 60-inch AWWA butterfly inlet valve gearbox and one (1) submerged 48-inch AWWA butterfly outlet valve gearbox in Basin 3 of the Terminal Reservoir. The work will also include the purchase and installation of one (1) new 60-inch AWWA butterfly valve gearbox, one (1) 48-inch AWWA butterfly valve gearbox, and the recoating of one (1) submerged 36-inch AWWA butterfly suction valve gearbox, all of which shall be rated for submersion. If the hardware on the 36-inch gearbox cannot be salvaged, it shall be replaced with stainless steel hardware. Depending on the size and configuration of the new gear boxes, they may need to be installed with a universal joint that allows for installation at a slight angle or using an adapter to maintain use the existing roof penetration to ensure proper operation and facilitate future maintenance.
